3	PURPOSE	Broad spectrum insecticide for surface spray application
4	APPEARANCE	White liquid

Exclude all persons and animals during treatment and until treated surfaces are dry. Do not apply direct to animals. Cover water tanks and aquariums before use.

11	RPE	Full face respirator or half face respirator with A1P3 filter and goggles
