






1	TRADE NAME	Oa2Ki Concentrate
2	ACTIVE INGREDIENT	Geraniol
3	PURPOSE	Organic Insecticide Concentrate for use against flying and crawling insects
4	APPEARANCE	Pale yellow liquid
5	CLASSIFICATION	  Flammable liquid and vapour, Causes serious eye irritation.
6	HANDLING /USAGE	Use in well ventilated areas. Do not eat, drink or smoke when applying product. Spray may mark or darken some absorbent materials or surfaces. These marks normally disappear within a few days. Protect any sensitive areas. Spray a small test area first. Oa2ki may affect the appearance and possibly damage polished or waxed surfaces. Cover any sensitive areas/surfaces before application.
7	MIXING	Dilute concentrate by adding 1-part concentrate to 7.5 parts water. Shake well. 500 ml concentrate makes 4.25 litres of ready to use product.
8	APPLICATION	Spray the product directly onto the insect pest to obtain complete coverage. Oa2ki® can be used both indoors and outdoors. Avoid spraying near highly polished wax surfaces. Do not spray directly onto animals, plants or foodstuff. Product may mark or darken absorbent surfaces. These marks should disappear within a few days but if in doubt, spray a small test area first. Note: Once the product is diluted to manufacturer recommendations it is not classed as flammable
9	RESTRICTIONS	Do not spray directly onto foodstuffs, plants, animals or pets. Do not direct spray/mist into the eyes or onto broken skin.
10	PPE	   Nitrile gloves, coveralls and goggles.
