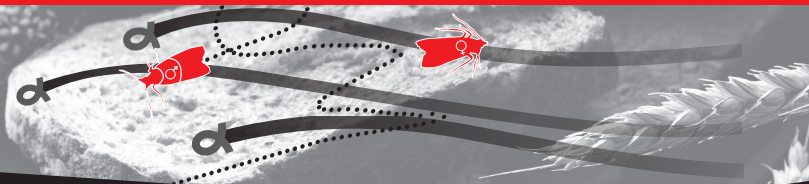

DIRECTIONS FOR USE:

USE ONLY AS DESCRIBED ON LABEL

Plot out a layout for the approximate placement of the dispensers before deploying them. The distance between the dispensers should be 8 metres on average, but where obstacles or obstructions are present the dispensers can be placed to accommodate the layout and air dynamics within the factory.

Keep the dispensers in the foil bag until use. Wear gloves when handling the dispensers.

The Dispensers need to be placed 2-3 metres above the floor and the clip fastened in place by a suitable adhesive.

Monitoring should be carried out using Pheromone monitoring traps such as Russell IPM RTU combo 4 traps on a weekly basis, the data recorded and assessments made by the PCO or other suitable person about the levels of insect infestation.

Dispensers should be replaced every 3 months.

This product acts by disrupting the mating between male and female moths. Populations of the pest insects are reduced as the adult insects die and are not replaced by the next generation. Continuous application will result in reduced levels of problem insects in all but the most severe infestations. This product should be used as a part of a pest management program.
